PUBLIC STATEMENT OF THE OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to intervene and participate in the Petition of PPL Electric Utilities Corporation for Approval of Its Act 129 Phase V Energy Efficiency and Conservation Plan (Petition).

On December 1, 2025, PPL Electric Utilities Corporation (PPL or Company) filed the Petition, pursuant to Section 2806.1 and 2806.2, of the Public Utility Code and pursuant to the Implementation Order entered by the Commission at Docket No. M-2025-3057329 on June 18, 2025. The five-year cost of the Company's EE&C Phase V Plan (June 1, 2026, through May 31, 2031) is projected to be \$307.5 million. PPL EE&C Petition at 6. The Company's programs are designed to achieve a total overall gross verified energy reduction of at least 828,231 MWh by May 31, 2031. *Id.* Also, the Company has a target to reduce peak demand below 151 MW by May 31, 2031. *Id.* at 7.

The Consumer Advocate determined to intervene in this proceeding to protect the interests of PPL's customers; to ensure that the proposed Phase V Plan and programs are in accordance with Act 129 and all other applicable statutes, regulations, and Commission Orders; and to ensure that any increase in rates resulting from the adoption of the proposed programs and any related expenses are just and reasonable.
